**Trending Taiwan - 10<sup>th</sup> Short

Authorization Agreement**

I, \_\_\_\_\_ (hereinafter referred to as 'I'), participate in the 'Trending Taiwan - 10<sup>th</sup> Short Film Competition,' organized by the Ministry of Foreign Affairs, Republic of China (Taiwan), and co-organized by Commonwealth Magazine Co., Ltd. I hereby guarantee that the submitted work is my original creation and all rights are legally owned by me. I agree to sign this Copyright Authorization Agreement (hereinafter referred to as the 'Agreement') and grant, without charge, permanent authorization to the organizers of the 'Trending Taiwan- 10<sup>th</sup> Short Film Competition.' The scope of authorization is as follows:

**Article 1 Object and Scope of Authorization**

I hold the copyright of the submitted work \_\_\_\_\_ (hereinafter referred to as 'the Work') and hereby grant permanent authorization to the organizers of the 'Trending Taiwan - 10<sup>th</sup> Short Film Competition' from the date of award announcement. This authorization allows the organizers to exercise the right of use of the Work globally, without territorial restrictions, under non-profit circumstances. The rights encompass reproduction, editing, adaptation, distribution, publication, public transmission, public broadcasting, and public display of the Work.

**Article 2 Guarantee Matter**

I hereby guarantee that the Work is my original creation and has not been awarded in any other public competition. In the event of any



discovery to the contrary, the organizers reserve the right to revoke the award and reclaim any prizes associated with this event. I have no objections to this action.

### **Article 3 Guarantee for Defect of Rights and Obligations of Litigation Assistance**

1. I hereby guarantee that I am the rightful owner of the copyright or any other related legal rights (including but not limited to text, recordings, music, videos, animations, illustrations, or portrait of actors within the video) of the Work. I have the authority to grant the authorization as stipulated in this Authorization Agreement. I also ensure that the authorization of the Work and this Authorization Agreement does not violate copyright laws or any other regulations. In the event of any legal violation causing damage to the organizers of the 'Trending Taiwan - 10<sup>th</sup> Short Film Competition,' I am willing to bear full legal responsibility and reimburse any damages incurred.
2. If there are third-party rights holders for the submitted work, I shall provide statements and cooperate in supplying relevant supporting documents (such as authorization letters or purchase receipts) to ensure that the submitted work can be used for promotional purposes by the organizers.
3. During the period of authorization, in the event that the organizers of the 'Trending Taiwan - 10<sup>th</sup> Short Film Competition' are challenged by any third-party claiming infringement of copyright or other related rights due to the use or exploitation of the subject matter under this authorization, I shall be notified in writing and shall assist in resolving the matter to safeguard the interests of the organizers. If, in the end, a court issues a final judgment or a settlement is reached with my consent, and the organizers of the 'Trending Taiwan - 10<sup>th</sup> Short Film Competition' are required to compensate the third party, I shall not only forfeit the award and return any prize money but also compensate the organizers for all damages incurred as a result (including but not limited to legal fees, lawyer fees, etc.).



#### Article 4 Award Collection Procedures

1. Winners are responsible for their own transportation, accommodation, and meal expenses related to receiving the award.
2. For winners who are citizens or entities of the Republic of China, must in compliance with relevant regulations of the Republic of China and the procedures of the Directorate General of Budget, Accounting and Statistics of the Ministry of Foreign Affairs, the prize money will be awarded in New Taiwan Dollars.
3. For winners residing outside the territory of the Republic of China or profit-making entities receiving awards, taxes and supplementary National Health Insurance (NHI) premiums in accordance with the law will be deducted. In compliance with relevant regulations of the Republic of China and the procedures of the Directorate General of Budget, Accounting and Statistics of the Ministry of Foreign Affairs, which may receive the prize money converted into foreign currency. The prize money will be paid in the equivalent foreign currency based on the exchange rate, and the winners will be responsible for any handling fees.

In consideration of the above, and to ensure my commitment, I hereby sign this Authorization Agreement in concurrence.
